WHEREAS, THE STATE UNIFORM CONSTRUCTION CODE REQUIRES THAT THE SAID PERMIT FEES CHARGED UNDER THE UNIFORM STATE CONSTRUCTION CODE AS ADOPTED BY THE ORDINANCES OF COMMERCIAL TOWNSHIP SHALL BE PERIODICALLY ADJUSTED TO COVER THE OFFICE OF THE CONSTRUCTION OFFICIAL.

- 8. PRE MANUFACTURED ACCESSORY BUILDING GREATER THAN 100 SQUARE FEET \$35.00. GREATER THAN 300 SQ. FT., \$35.00 PER 1,000.00 OF COST.
- 9. DEMOLITION OF RESIDENTIAL STRUCTURE OR ACCESSORY BUILDING, \$50.00. ALL OTHER USE GROUPS \$100.00.
- 10. ROOFING AND SIDING ON USE GROUPS R-3 AND R-4 SHALL BE \$46,00 EACH.
- 11. RELOCATE BUILDING OR STRUCTURE TO NEW LOCATION: FLAT FEE OF \$200.00.
- 12. REINSTATEMENT OF PERMIT, \$50.00 APPLICABLE AFTER ONE YEAR OF ISSUANCE DATE, PLUS VOLUME INCREASE IF APPLICABLE AT TIME OF REINSTATEMENT.

- 13. FOR INSTALLATION OF ABOVE GROUND SWIMMING POOLS R-3 or R-4 \$50.00.ALL OTHERS \$80.00.
- 14. LEAD HAZARD ABATEMENT WILL BE A FLAT FEE OF \$70.00 WITH A \$50.00 FEE FOR A CERTIFICATE OF CLEARANCE-LEAD ABATEMENT 5:17.
- 15. PRE-MANUFACTURED HOME/PRE-EXISTING HOME (SEE SECTION F) MOBILE HOME ANCHORAGE AND SUPPORT SYSTEM WITHIN A MOBILE HOME PARK MINIMUM FEE OF \$50.00 PER UNIT.
- **B. TRAINING AND CERTIFICATION FEES.**

F. PRE-MANUFACTURED, MODULAR, AND PRE-BUILT DWELLINGS THE FEE SHALL BE BASED ON \$50.00 PER ONE THOUSAND DOLLARS OF THE TOTAL COST OF ALL WORK TO BE PERFORMED ON SITE (WHICH IS NOT FACTORY INSTALLED. i.e. FOUNDATIONS, STEPS, DECKS, PORCHES, HEATING SYSTEMS, PLUMBING, GAS AND ELECTRICAL HOOKUPS). PROVIDED THAT THE MINIMUM FEE SHALL BE \$200.00. ANY UPDATES SHALL BE BASED ON \$50.00 PER \$1,000, OR FRACTION THEREOF, HAVE COST.

MOVING PERMIT FEES AND INSPECTIONS FOR MOBILE, MODULAR AND PRE-EXISTING STRUCTURES.

SECTION 1. NO MOBILE HOME, MODULAR HOME OR ANY OTHER STRUCTURE OF ANY KIND SHALL BE MOVED INTO THE TOWNSHIP OF COMMERCIAL FOR PURPOSES OF PERMANENT LOCATION THEREIN, OR TEMPORARY LOCATION THEREIN FOR MORE THAN TWENTY-FOUR (24) HOURS WITHOUT HAVING OBTAINED A MOVING PERMIT FROM THE TOWNSHIP CONSTRUCTION OFFICIAL.

SECTION 2. PRIOR TO ISSUANCE OF ANY MOVING PERMIT UNDER THIS ORDINANCE, THE CONSTRUCTION OFFICIAL SHALL ASCERTAIN THAT THE STRUCTURE IS EITHER NEW AND NOT PREVIOUSLY OCCUPIED BEING SOLD BY EITHER A DEALER OR MANUFACTURER, OR SHALL ASCERTAIN BY PERSONAL INSPECTION THAT THE MOBILE HOME, MODULAR HOME, OR STRUCTURE MEETS ALL OF THE REQUIREMENTS OF THE BOCA BASIC BUILDING CODE AND THE ORDINANCES OF COMMERCIAL TOWNSHIP. THE CONSTRUCTION OFFICIAL SHALL ALSO ASCERTAIN THAT THE MOBILE HOME OR MODULAR HOME, IRRESPECTIVE OF WHETHER NEW OR USED, CONTAINS THE CERTIFICATION OF THE NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS AS MEETING THE CODE REQUIREMENTS. AFTER MAKING THE DETERMINATION REQUIRED IN THIS SECTION, THE CONSTRUCTION OFFICIAL SHALL ISSUE A MOVING PERMIT. THE COST OF WHICH SHALL BE TEN (\$10.00) DOLLARS.

SECTION 3. INSPECTIONS OUTSIDE OF COMMERCIAL TOWNSHIP. ALL PERSONAL INSPECTIONS PROVIDED FOR UNDER SECTION 2 HEREOF .OF ANY STRUCTURE THAT SHALL BE PHYSICALLY ENTERING THE JURISDICTION OF COMMERCIAL TOWNSHIP. TILE COST OF SUCH INSPECTION SHALL BE BORNE BY THE APPLICANT FOR A MOVING PERMIT. IN ADDITION TO THE PERMIT FEE UNDER SECTION 2, ALL THE FOLLOWING RATE: THIRTY FIVE (.35) CENTS PER MILE FOR EACH MILE OF THE ROUND TRIP TO AND FROM THE PLACE OF INSPECTION PLUS TWENTY-FIVE (25.00) DOLLARS PER HOUR FOR TIME SPENT BY THE CONSTRUCT ION OFFICIAL IN TRAVEL AND INSPECTION OF THE UNIT INVOLVED.

SECTION 4. NO PERMIT SHALL BE ISSUED UNDER THIS ORDINANCE UNLESS IT IS DETERMINED BY THE CONSTRUCTION OFFICIAL THAT THE APPLICANT THEREFORE HAS A PERMANENT LOCATION FOR THE MOBILE HOME, MODULAR HOME OR STRUCTURE IN THE TOWNSHIP OF COMMERCIAL. ON WHICH SAID UNIT CAN BE INSTALLED IN FULL COMPLIANCE WITH ALL APPLICABLE FEDERAL, STATE AND LOCAL REGULATIONS AND HAS ALL PERMITS REQUIRED THERETO.

SECTION 5. THE PERMIT REQUIRED UNDER THIS ORDINANCE SHALL NOT BE REQUIRED FOR THE MOVEMENT OF A MOBILE HOME, MODULAR HOME OR OTHER STRUCTURE THROUGH COMMERCIAL TOWNSHIP ON A PURELY TRANSIENT BASIS, FROM A PLACE OUTSIDE THE TOWNSHIP TO A DESTINATION OUTSIDE THE TOWNSHIP ON THE STATE HIGHWAYS OR COUNTY ROADS WITHIN THE TOWNSHIP, SO LONG AS SUCH UNIT DOES NOT REMAIN FOR MORE THAN TWENTY-FOUR (24) HOURS IN THE TOWNSHIP OF COMMERCIAL.

SECTION 6. PENALTIES, VIOLATION OF ANY PROVISION OF SECTION (G) OF THIS ORDINANCE SHALL BE PUNISHABLE BY A FINE NOT TO EXCEED FIVE HUNDRED (\$500.00) DOLLARS, AND EACH DAY DURING WHICH VIOLATION TAKES PLACE MAY BE DEEMED A SEPARATE VIOLATION.
